

AFFIDAVIT
of
TEMPORARY CUSTODY and LEGAL RESPONSIBILITY
For
DETERMINING DISTRICT 87 RESIDENCY

This form is used by District 87 to help it determine the residency of a pupil for enrollment purposes. By state law, the residency of a pupil is the residency of the person who has legal custody of the pupil. Typically, the natural parent or a person established by a Court order has custody of the pupil. Occasionally, a pupil lives with someone other than their parent or legal guardian. This form is used when an adult other than the natural parent or legal guardian assumes and exercises temporary custody and legal responsibility for the pupil for reasons other than the pupil's access to the educational programs of District 87.

This form should not be used where a Court has determined custody, where an adult is receiving public aid on behalf of the pupil, or where the pupil is homeless (sharing housing due to lack of housing, economic hardship or similar reason). Only a Court can officially change legal custody and responsibility for a child.

This form shall be completed and signed by both the pupil's natural parent(s) or legal guardian(s) who are assigning legal responsibility to another adult as well as the adult(s) who has (have) assumed and exercise(s) legal responsibility for the pupil.
